Pacific Northwest Region (Regional Office) Forest Service

Introduction:

The Pacific Northwest Region (Region 6, or "R6") of the US Forest Service intends to advertise and fill the full-time permanent position of Senior Review Appraiser that will focus on the Forest Service's appraisal needs in Oregon and Washington. The position is in the 1171 Series (Appraiser) at the GS-13 level. The position will be offered with duty location negotiable and flexible telework. A hiring incentive may be offered.

This is NOT a vacancy announcement. The purpose of this outreach notice is to inform potential applicants about this upcoming opportunity, and to solicit expressions of interest from potential applicants. Please circulate this Outreach Notice to as many potential candidates as possible, as we are seeking a diverse pool of qualified applicants. Telework eligible: Yes, as determined by agency policy. The position is eligible for maximum telework, up to 8 days per two-week pay period, or traditional office.

Overview of Duties Associated with the Position:

The position is part of the Region 6 Recreation, Lands and Minerals Directorate that provides professional and technical leadership and management direction for boundary management, title claim and encroachment resolution, minerals management, land acquisition and exchanges, land conveyances and special use authorizations on/for National Forests in Oregon and Washington.

Under the working title of Senior Review Appraiser, the position primarily supports landownership adjustments (purchase, land exchange, and conveyances) as well as special uses and other agency functions. A small portion of the work may support the Forest Legacy Program. The incumbent is responsible for providing a wide range of valuation services, including contracting for real property appraisals and performing technical appraisal review duties, as assigned by the Regional Appraiser.

Additionally, the incumbent provides input to and assists with providing guidance and training, establishing regional valuation policy, and assuring quality control for valuation activities. Delegated authority can be extended to the incumbent to approve appraisals up to and including \$10,000,000.

Qualification Requirements:

The applicant must possess a Certified General Appraiser license in their name from a State in compliance with Title IX of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989 (Federal employees need only be licensed or certified in one State or territory to perform real estate duties as Federal employees in all States or territories, per the Office of Management and Budget Bulletin No. 92-06, dated March 16, 1992).

Additionally, a professional appraisal designation or accreditation meeting the following criteria is a minimum requirement for the Senior Review Appraiser position. A qualified/acceptable appraisal designation or accreditation is one that requires approved classroom training in appraisal practice, experience requirements, a demonstration appraisal report or appraisal review report, and a comprehensive qualifying examination in the attainment of the credential.

Duty Station Specifics:

Organizationally this position is situated in the Region's Recreation, Lands & Minerals unit that is based out of the Pacific Northwest Regional Office, 1220 SW 3rd Avenue, Portland, OR 97204.

The position may be offered with duty location negotiable upon selection, with flexible telework or a traditional office environment. A telework agreement allows working from home up to 8 days per two-week pay period.

The locality rate for the GS-13 salary is dependent on duty location, and the position includes standard Federal benefits, and special salary rates apply.
